

We are excited for the potential to host you as a vendor at Vendor Artisan Markets! This is a market for handmade and handcrafted items made BY THE VENDOR. If you do not physically make what you sell, then this is not the market for you but we thank you for your interest. There are some exceptions if a mission or charity is involved.

We will need to approve each vendor before committing you to any market. You will receive a response whether selected or not. Once you have been selected you will receive an email with further information and instructions.

TWO DAY VENDORS

Most of our 2-day events are INSIDE and the vendor may leave their display overnight at their own liability and discretion.

PARKING

Parking varies per event location. At some market locations, we will include parking for you within your fee but regardless we will always provide you with local options.

SET UP

-There are three different types of spot sizes in our events and it varies per location. The spot sizes are 10x10 tent spots, 6x6 spots and 8x8 spots.

-Spots will be assigned and an email with a map will be sent out a few days before. When you get there please find your designated placard. The areas will be marked with tape on the ground

-All tables may be subject to prior approval. PLEASE KEEP DECOR AS NEUTRAL & CLEAN AS POSSIBLE

DAMAGING PROPERTY

You may not use anything on the walls or floors that will damage the property of any event location. No tapes, tacks, affixing, etc. Any spills or damage caused by vendor will be vendors responsibility for repair/cleaning.

COVID POLICIES & PROCEDURES

We will be doing everything in our power to host a safe event. Stay home if you are sick.

INTERNET

WIFI availability varies per location.

EVENT SHARING

Vendors are required to post on all social media outlets, websites, emails blast campaigns, etc. the events graphics provided by Vibe Artisan Markets when they are provided in a later email.

CONFIDENTIALITY

No business/contracts/organization information regarding Vibe Artisan Markets shall be shared outside the event pertaining to the event, event host, any form of communication, venue or vendors by the event host, venue staff or vendors. Forms of communication include but are not limited to: emails, text, phone calls, forms, etc. Nothing pertaining to the market is to be shared to any other event host, worker, facility, etc. All cross promotion of other markets is prohibited.

HEALTH PERMIT

All food vendors ARE REQUIRED to have proper permitting if needed by the city the event is being hosted in. All permitting and paperwork are the responsibility of the vendor.

ELECTRICITY

Electricity availability varies per location.

LIGHTING

Lighting can be dim at some venues. We always encourage vendors to bring their own batter operated lighting.

SECURITY

Vibe Artisan Markets does provide security during 2-day events, not 1-day events, for the entire event but will not manage/secure the items in your booth. Vibe Artisan Markets shall have no liability of any kind for loss, damage or injury to Merchant, his/her property, or merchandise. All expenses of any kind connected with the transporting, packing, unpacking and insuring of Merchant's property or merchandise shall be paid by the Merchant. All expenses incurred by the Merchant during any Vibe Artisan Markets will be paid by the Merchant. Vibe Artisan Markets does NOT assume liability or responsibility for any merchandise that is left unattended during show hours or non-show hours.

BANKING SERVICES

Vibe Artisan Markets staff CAN'T make change for you. Make sure to bring enough change to the Market each day. There are banks nearby.

SMOKING

Smoking is prohibited at Vibe Artisan Markets and there will not be a designated smoking area outside. If you must smoke, please go off property.

PHOTOGRAPHY & PROMOTION

All vendors agree to allow use of video and photography taken by Vibe Artisan Markets organizers at the event for promotional purposes.

Any photos taken by the event are the property of Vibe Artisan Market.

WEATHER

Vibe Artisan Markets are rain or shine and non-refundable & non-transferrable.

PAYMENTS

-Payment is due upon the completion and return of any and all forms.

-A 7 day payment time pardon is available and need to be requested by email.

-If not paid by the 7 day deadline, your spot in the market will be RELEASED AND YOU WILL NO LONGER BE IN THIS MARKET.

REFUND POLICY

-ALL Payments/Markets are Non-refundable & Non-transferrable in ANY situation.
